Construction Management Plan

A Construction Management Plan is a plan that outlines the proposed building works to be undertaken and how the Client / Contractor intends to manage the project to minimise the impact on the local residents during the works.

It is important to note that this plan is not the same as a Construction Phase Plan, albeit there is considerable overlap due to this document detailing how the Principal Contractor will plan, manage, monitor and

coordinate their works throughout the construction phase.

A Construction Management Plan is not a legal requirement; rather, this document is requested

submitted by councils as part of the planning application process for new developments or as a Planning Approval Condition, which needs a Construction Management Plan to be in place before work on-site can commence.

Review of Safe Systems of Work (RAMS)

Risk assessments and method statements are two of the most common types of health and safety

documents within the construction sector. When carrying out an activity on site, one or more commonly both of these documents will be required.

Risk assessments are used to record hazards identified in the workplace, assess the likelihood and severity of risks and to plan adequate control measures to eliminate or reduce those risks.

Method Statements also referred to as a "Safe System of Work" — build on the information outlined in risk assessments, expanding on hazard identification and management and control measures. They detail how specific activities can be carried out safely — describing control measures and safety precautions and how these can be implemented/what control equipment should be used

NCC can provide an extensive support service to Principal Contractors which includes a Risk assessment and method statement review service. As the Principal Contractor you have an obligation to ensure

that contractors working on projects have provided the relevant information and are controlling the risks

to people on the project to acceptable levels.

By engaging with NCC, you can provide the documents for an initial review by one of our fully trained and competent consultants who will then provide a review form back to you so that this can be sent onto the sub-contractor for consideration and making any improvements that are required. CDM Principal Designer Role

The HSE state that a principal designer is appointed by the client to take the lead in planning, managing, monitoring and coordinating health and safety during the pre-construction phase (design and planning stage) of a project involving, or likely to involve, more than one contractor. The role of the designer is

defined as; that in the construction Design and Management Regulations 2015 the designer will provide professional control over the pre-construction phase and have the relevant skills, knowledge and experience.

A principal designer has an important role in "influencing how the risks to health and safety should be managed and incorporated into the wider management of a project. Design decisions taken during the pre-construction phase can have a significant effect on whether a project is delivered in a way that secures health and safety. The principal designer's role involves close cooperation with the client and the principal contractor and coordinating the work of others in the project team to ensure that significant and foreseeable risks are managed throughout the design process.



Duties of a NCC Principal Designer

A NCC consultant will form a close partnership with the client and will be the ultimate reference on Health and Safety matters for the project. We ensure that the client is being regularly updated on Health and Safety matters that have an impact on the project.

We ensure that the subject of Design Risk Management is kept at the forefront of all pre-construction design works and ensure the effective coordination between designers, architects and structural engineers on the project.
